# What Price, Freedom?

The documents below are found in their original form in Register of Manumitted Slaves - 1800 - 1828 held at The Albany County Hall of Records, Albany, New York

ven when manumitting enslaved persons, enslavers refused to give up power or privilege. One of the consequences of slavery was how it corrupted the minds of the enslavers. Enslavers saw no conflict or complication in their claims regarding freedom and the existence of enslavement. In the example of manumission offered below, from enslavers who lived right in New York Capital Region communities, the enslaver offers freedom to someone held in bondage. But, instead of simply agreeing to free the enslaved, conditions are added that transform the offer of freedom into another form of bondage. In the record copied here Elizabeth Ten Broeck offers Susanah her freedom, but as a condition of freedom requires Susanah to return without pay to complete numerous chores. In other manumission documents those in bondage were required to make scheduled payments to enslavers; late payments would even incur interest. Isn't this a strange way to offer freedom? It is clear the enslaver is divided in the desire to provide freedom and yet looking to find a way to maintain the enslavement relationship.

We give freedom to ourselves, we enable freedom in others.

#### Harriet Tubman National Monument -A call from National Trust for Historic Preservation

In a letter dated November 16, 2012, Stephanie Meeks, President of the National Trust for Historic Preservation, asked President Obama to use his executive authority under the Antiquities Act to designate a national monument to Harriet Tubman. Meeks' letter pointed to the National Park Service's work of elucidating and articulating Harriet Tubman's story and legacy through its Special Resource Study, noting a number of potential locations for the designation including the Harriet



Tubman Home, the Bucktown Village Store, and Poplar Neck.

Harriet Tubman is remembered for her role as a conductor in the Underground Railroad and as an advocate for human rights during and after the Civil War. Since her passing one hundred years ago this coming March in 2013, her story and her meaning have witnessed great resurgence. In the past 140 years nearly half a dozen researched biographies and hundreds of youth focused books, commemorative stamps, several public statues and an uncountable number of public remembrances have celebrated Harriet Tubman's life and legacy. Dedicating a national monument to Harriet Tubman can inspire us all to carry on her legacy that is part of our American heritage.
